


workperiode and presentation at Billytown, The Hague

Within this project, we conceived the space of Billytown as a rehearsal space. For six weeks there were 'rehearsal-sessions' that could be seen as as many performances: the boundary between rehearsal and performance was dissolved or remained ambiguous. We developed an ever-changing exhibition, searching for the space between practice and presentation. It was a space for collaborative making and dialogue. Whether these sessions would come to an actual 'end point' - and if so, how - was left open. However, we continually resumed things and brought them together to a 'state of affairs' during the final weekend.







